- ECan provide \$15,000/year funding for wages to maintain networking and marketing including comprehensive website and social media, signs, educational resources, plus some wages towards the cost of planning and running the 2020 braided rivers symposium
- Some 20 months remains of a 3 year Lotto grant to develop and foster partnerships with community groups to protect and restore braided river bird habitats (mostly wages but also some traps and signs)
- LINZ will fund the (one-off) outgoing costs (venue and catering) for the upcoming 2020 braided rivers symposium, however this may be postponed due to Covid-19.

The amount below are funds in hand as of 23 January 2019. All of our current funding from Lotto and ECan in hand is specifically allocated to existing braided rivers projects outlined above, including contracted wages and river bird surveys anticipated in the coming season. We are holding \$3,304 in hand from DOC and a specific donation to control black-backed gulls, also earmarked for the coming season. In sum, we do not have funds to start this new separate project.

In an ideal world, communities would understand the cascading risks posed by climate change. Individuals and communities would knowledgably participate and contribute to decisions and be enabled to take action. Everyone would understand that decisions will need to continuously adjust as weather patterns and sea levels rise and risks such as biosecurity come into focus. Everyone—including the farming sector—would place climate risk and emerging opportunities at the forefront of their decisions. And healthy ecosystems would be recognised as indispensable to the efforts to mitigate and adapt to climate change.

In the real world, while there is an enormous body of peer-reviewed research on climate change and robust strategies for mitigation and adaptation, the information is largely inaccessible and/or incomprehensible to the lay person. That disempowerment results in denial, fear, anger, and resentment, all of which impede rational discussion and sound decision making.

Our goal is to create a resource and information hub to share learning, knowledge, and practical actions to address the climate emergency in Canterbury. The content will draw on peer-reviewed research and proven outcomes in a wide range of science disciplines, but presented in accessible ways that empower and enable people to develop climate resiliency for themselves, their whanau, & their communities. It will do so using the same proven networking and communications model as BRaid uses for braided rivers.

How do you know there is a need for your project, programme or service?

Just before the 2019 braided rivers seminar at Lincoln University, student strikes were calling for action. Environment Canterbury was one of several regional and district councils that declared a climate emergency. But the details of what this means to individuals and communities were (and still are) lacking. The manager of BRaid, who has a background in climate change and community development, presented on the impacts of climate change to braided rivers in July. As winter feeding grounds for critically endangered endemic and taonga braided river bird species extend from the mountains to the open ocean, the problems associated with braided rivers are complex and far reaching. The presentation exposed the implications of climate change across all sectors and communities, 'from the mountains to the sea'. Within days, we were contacted by other groups and organisations (including ECan and the Hurunui-Waiau Zone committee) requesting more information and presentations to communities on climate change. We have subsequently found that groups and communities are struggling to understanding the implications of something not everyone is completely sure is real, why both mitigation and adaptation is necessary, and for those wanting to respond, how and what they can do to develop climate resiliency. We have also found sound strategies being undertaken by groups relevant to their own sector, but these efforts are often concentrated and siloed because they each have their own mandate and priorities.

BRaid's mandate and funding is centred on braided rivers, not broadscale climate change adaptation and mitigation strategies at community, group, and individual levels. We do not have the funding to divert from our core mandate to develop a cross-sector networking and communications hub to enable this. We do, however, have the knowledge, expertise, capability, and time-capacity to do so. And we are acutely aware of the urgency.

We have been able to reach over 70,000 people when it comes to bad news around braided rivers. We believe we will reach more than that with this project, as climate change affects all sectors, cultures, and age groups, however it it takes time to build the necessary networks.

What difference are you hoping your project, programme or service will make to your community?

Our goal is create a responsive resource and information hub; to share learning, knowledge, and practical actions to address the climate emergency by enlisting the free services provided by nature. The content will draws on peer-reviewed research and proven outcomes in a wide range of science disciplines including human health and well-being. Our goal is Individuals will be able to knowledgably and collaboratively work to become climate resilient for themselves, their whanau, and their communities.

The most cost-effective and practical strategy is to rapidly mobilise the free ecosystem services provided by nature. To enable these services, we must restore the habits and biodiversity that provide them. And we must do so before they are irretrievably lost. These

services will help:

- reduce carbon emissions into the atmosphere
- sequester atmospheric carbon back into the ground
- reduce the economic and social upheaval of rising sea levels and severe weather
- replenish biodiversity across multiple habitats, including soils
- restore health to waterways
- restore mahinga kai
- increase agricultural productivity while reducing emissions
- create new business opportunities
- reduce the projected impacts of climate change on human health and wellbeing

We hold chaired meetings every 3-4 months, accounts are managed by a paid treasurer, and we are audited annually. All reporting to Charities and our current funding organisations is up to date. We use a Risk Analysis and Management System for outdoor field works and indoor work, including working with schools. We use best-practice advise from DOC braided rivers Technical Advisory Group and from ECan biodiversity team. All advise and information we given in person and on the website has been reviewed by these and other experts including NIWA.

What information do you plan to collect to help you understand how successful your project, programme or service has been?

We measure success by level of engagement and feedback from our partners and community groups. Our 200+ page website is the go-to resource for students, researchers, and community groups alike and recognised by DOC as the primary resource for braided rivers. Facebook posts reach from 130- 77,000 people. Our educational materials including signs are used widely by community groups, schools and by ECan and DOC, and our seminars and workshops are booked out and waitlisted. We will use the same benchmarks and a strategy of continuous improvement through updating resources and information, and evaluation and assessment to ensure the goals of the project are being met.

If you are aware of other groups or organisations providing a similar project, programme or service, how is yours different or complementary?

We undertook a comprehensive survey of websites whose goal was to provide a 'one stop shop' source of information and showcase for groups and activities in relation to climate change solutions. Most focus on climate problems, demands for government and corporate action to divest from fossil fuel investments and de-carbonise the economy (a term that few really understand). By design BRaid works entirely through co-operation and partnerships across multiple sectors to share knowledge and resources. These include iwi, individuals, schools, community groups, local and regional councils (primarily ECan) and DOC. We also work with advice from Lincoln, Otago & Canterbury Universities plus Crown Research Institutes NIWA and Manaaki Whenua Landcare Research.

This project aims to do the same, by inviting cross-sector participation and being response to feedback.
